

Privacy Policy Updated on: March 26, 2021

Asteroid PC Inc. (Meteroid Pc.) respects the privacy of its customers and visitors and is committed to protecting the personal information of its customers and visitors. This Privacy Policy covers the site www.asteroidpc.com. We collect no personally identifiable information about you when you visit our site unless you choose to provide that information to us or as specifically outlined in this Policy.

This Policy describes our general principles for the collection and use of information from customers and visitors to our Web sites. We want to ensure that you understand how we will and will not use the information you entrust to us.

For visitors, we've structured our Web sites so that, in general, you can visit us on Web without identifying yourself or revealing any personal information.

TYPES OF INFORMATION ASTEROIDPC.COM COLLECTS

Asternid Pr., will not otherwise disclose customer personal and account information unless Asternid Pr., has reason to believe that disclosing such information is necessary to identify, make contact with, or bring legal action against someone who may be causing harm or interfering with the rights or property of Asteroidpc.com, our customers, or others. Alteraid Pr. may provide information to regulatory authorities and law enforcement officials in accordance with applicable laws.
